## 4 NBS BRS (and related UserGuide)

- 4.1 Questions to be answered when the secondary legislation in Sweden is approved:
  - Should we remove the "red arrows" from "Error! Reference source not found."
  - In chapter 5.7.2.1 we say:

Finland will send ESS Schedule Time Series in UTC+2, while the Nordic balance settlement will be done in UTC+1, i.e. the settlement will be based on ESS Schedule Time Series for two different days (the first hour of a "balancing day" will be sent the day before the last 23 hours of the "balancing day").

#### Decision:

- Remove arrow 6 and 7, keep arrow 9 and 10 with a comment "only used in Sweden";
- Rename Svenska Kraftnät to Svenska kraftnät, throughout the BRS;
- The text in chapter 5.7.2.1 will be replaced with:

## 7.1 NEG set of schemas

The NEG set of schemas are shown in Appendix B

## **Decisions:**

- For the common NEG set of schemas, we make one zip file with two main structures; one for ebIX® based schemas and the second for ENTSO-E and ENTSO-E based NEG schemas.
- In addition, we make (for the time being) two sets of xml schemas for special processes, i.e.
  - NBS
  - Market Operator (renamed from NPS)
- The Auction Specification Time Series schemas used by Energinet.dk will not be published as a separate set of xml-schemas.

#### Action:

- Anti will verify if all three sets of NBS xml schemas are needed at www.ediel.org.
- Anti/Eveliina will verify if we can replace the current "auctionspecification**document**" with the latest version, in the NPS set of XML schemas. The changes are:
  - Update (correction) of urn-ediel-org-neg-masterdata-auctionspecificationdocument-1-1.xsd, where the text "document" is added to the namespace "auctionspecificationdocument" and "Capacity is removed from the root element "Capacity AuctionSpecificationDocument".
- All are asked to find what versions of xml-schemas are used to day in different projects and come up with proposals for new schemas and/or sets of schemas that should be published at www.ediel.org.
- Ove will make a proposal for a new layout of the Common Documents at <a href="www.ediel.org">www.ediel.org</a>

  - Addition of "A02 No" to Divisible
  - Addition of "A01 Yes" to BlockBid
- NEG Auction Specification Document and NEG ERRP Reserve Allocation Result Document:
  - Addition of "A95 Frequency containment reserve" to BusinessType
  - Addition of "A97 Manual frequency restoration reserve" to BusinessType

## 19.1 NTC ToR and Working Program

MSG has agreed on a new organisational structure, from 2017, in which RMG is one of four empowered groups that will report to MSG. MSG has placed NEG as a subgroup under RMG, while NTC still is a subgroup under NEG. As a consequence of the changed organisational structure, NEG and NTC have been asked to draft (update) their Terms of Reference (ToR) and Working Program for 2017. Draft ToR and Working Program for 2017 for NTC and NEG were distributed to NTC January 10<sup>th</sup>.

The documents were reviewed and updated.

#### Action:

• Ove will rewrite the documents based on comments during the meeting and resend to NTC.

## 19.2 New Nordic NEMO (EPX)

Jon-Egil informed that there will be established a new Nordic NEMO (EPEX) by the end 2017. Among others this means that all text related to Nord Pool and NPS must be replaced with Market Operator in all BRSs, User Guides etc.
